Beginning at the intersection of the centerline of the Cape Coral Bridge and the centerline of the Caloosahatchee River main channel; thence run southwestwardly along the centerline of the main channel of the Caloosahatchee River to a point west of the centerline of Deep Lagoon; thence east to the centerline of Deep Lagoon and south along the centerline of Deep Lagoon to an intersection with the centerline of McGregor Boulevard; thence northeasterly along said centerline to an intersection with the centerline of College Parkway; thence easterly along said centerline to an intersection with the centerline of Summerlin Road; thence northerly along said centerline to an intersection with the centerline of Brantley Road; thence easterly along said centerline to an intersection with the centerline of U.S. 41; thence southerly along said centerline to an intersection with the centerline of Daniels Parkway; thence easterly along said centerline to an intersection with the centerline of the former Seaboard Coastline Railroad Right-Of-Way; thence northerly along said centerline to an intersection with the centerline of Colonial Boulevard; thence westerly along said centerline to an intersection with the centerline of U.S. 41; thence northerly along said centerline to an intersection with the centerline of the Caloosahatchee River main channel; thence southwestwardly along the centerline of said main channel to an intersection with a line running perpendicular to the centerline of said main channel; thence northwestwardly along said line to the centerline of Hancock Creek at the mouth of said creek; thence run northerly and northwestwardly along the meandering centerline of said Hancock Creek, across Hancock Bridge Parkway and continuing northwestwardly along said Hancock Creek centerline across Pondella Road to an intersection with the centerline of Yellow Fever Creek, said intersection being approximately 6400 feet northerly from Pondella Road along said meandering centerline of Hancock Creek; thence run northwestwardly along said centerline of Yellow Fever Creek to an intersection with the centerline of State Road 78; thence run southwestwardly along said centerline to an intersection with the centerline of Del Prado Boulevard; thence southerly along said centerline to an intersection with the centerline of Viscaya Parkway; thence westerly along said centerline to an intersection with the centerline of Country Club Boulevard; thence southwestwardly and southerly along said centerline to an intersection with the centerline of Retunda Parkway; thence westerly and southwestwardly along said centerline to an intersection with the centerline of Southeast 26<sup>th</sup> Terrace; thence westerly along said centerline to an intersection with the centerline of San Carlos Canal; thence southerly, southeasterly, southerly and westerly along said centerline to an intersection with the prolongation of the centerline of Southeast 1<sup>st</sup> Court, said prolongation being south of Southeast 31<sup>st</sup> Terrace; thence southerly along said prolongation line and southerly along said centerline of Southeast 1<sup>st</sup> Court to an intersection with the centerline of Southeast 32<sup>nd</sup> Street; thence westerly along said centerline to an intersection with the centerline of Santa Barbara Boulevard; thence southerly along said centerline to an intersection with the centerline of Cape Coral Parkway; thence run easterly along said centerline and the centerline of Cape Coral Bridge to an intersection with the centerline of the Caloosahatchee River Main Channel and the Point of Beginning.
